Safeguard Enterprise is for the large publisher or corporate enterprise that needs to protect high value or confidential information, published in PDF format, whether for sale to the public, made available to third parties, or used for internal control and protection.

# PROTECT YOUR PDF DOCUMENTS FROM UNAUTHORIZED VIEWING, COPYING, PRINTING AND DISTRIBUTION

Safeguard Enterprise protects your PDF documents from unauthorized viewing, copying, sharing, modifying, printing (including how many times), and saving. Control how long your documents are viewed, and instantly revoke access in real-time. Prevent your PDF content from being readily pirated by stopping screen shots from being taken.

The enterprise administration system enables you to log system, user, and document activity/events (e.g. when a document is viewed or printed), generate reports (e.g. which customers have been given access to document x), view statistics (e.g. how many users are registered), apply batch changes (e.g. grant all users access to a document or publication in one go), and suspend documents to enforce specific document start/usage times. Advanced search, sort, and reporting facilities enable you to find information quickly and easily across a very large number of records.

Safeguard Enterprise protects PDF documents no matter where they reside, enforces the security policy governing their use, and allows you to dynamically change how that information is accessed at any time, even after distribution.

# Totally automated document security

Multiple PDF documents can be protected and DRM controls applied automatically (without manual input or user intervention) using our secure PDF command line protection utility. This also provides quick and simple integration into your existing web based applications (where PDF encryption is required on-the-fly) without the need to use an API.

Our e-commerce integration module works with your existing ecommerce system to help provide 24x7 delivery of protected documents. On successful purchase, customer information is automatically entered into the administration system (without the need for manual input) and license files are emailed to your customers or displayed on a web page so they can start using your protected PDF documents straight away.

# Subscription Services

For publishers selling subscription services, Safeguard Enterprise enables you to manage your subscription base effortlessly by providing individual publication expiry on a user basis. You can also choose when the document expiry message (or redirection to a URL of your choice) is displayed (e.g. 5 days before a document expires), giving users ample time to renew their subscriptions.

# Simple to Use, Simple to Administer

A simple to use web-based administration system (hosted by us or by you) lets you control access to your secure PDF documents in real-time.




Diagram 1: Web based administration system

Safeguard Enterprise records all document protection options on the administration system, and you can customize record displays, add and edit descriptions. The system can be completely backed up and restored, or you can export only certain sections of data. For extra security, a manual logon/logoff process is provided.
