**Police Colonel Ret. Moshe Duvdevany** is today the head of the security division of the Ministry of tourism. After a full career in the IDF and then the Police, Moshe Duvdevany has been involved in Security throughout his career. Best known in Israel for special event security, such as at the Maccabi Games, an event that is the leading Jewish Sporting event in the world, Duvdevany has been instrumental in making Israel's hotels safer by instituting policies and procedures and implementing special programs for coordination between Hotel Security and the Israel National Police and other agencies. Tourism and Terror, will be the subject of Colonel Duvdevany's presentation which he has presented all over the world, including Mumbai, after the multi action capability terror attacks in that city which targeted the leading Hotel in Mumbai.



**Dr. Tania Glenn** responded to the terrorists' attacks at the Murrah Federal Building in Oklahoma City in 1995 and to Ground Zero in New York City in 2001, as a first responder and licensed clinician. In responding to manmade and natural disasters, Tania also reported to New Orleans after Hurricane Katrina in 2005. Having worked with thousands of homeland defense and security professionals in supporting multiple military campaigns and/or

critical incidents, Dr. Glenn specializes in the identification and treatment of severe stress and trauma. Dr. Glenn has practiced psychology for twenty years interacting with professionals from

**Dr. Ross L. Riggs** has been the Director of Security Consulting Investigations, LLC since 2006. He has also served as the Security Advisor for Mission Agency/NGO's in Central & Eastern Europe and Mediterranean since 2001. Former Chief of Police, Retired from the Louisville Ohio Police Department, he has over 38 years of combined law enforcement and military experience.

**Bob Palestrant** has over three decades of experience serving South Florida as a paramedic/firefighter, registered nurse and emergency manager. He served in multiple command level positions while at Miami-Dade Fire Rescue including that of Fire Chief at Miami International Airport, Operations District Chief, Director of the Office of Emergency Management and Homeland Security, and as the first Division Chief for Domestic Preparedness. As Domestic Preparedness Chief, his responsibilities included Homeland Security, management of major pre-planned events, and serving as department liaison for all federal organizations, the military, and state and local law enforcement agencies. Palestrant was a member of multiple federal, state and regional anti-terrorism workgroups, and worked with the Defense Threat Reduction Agency (DTRA), to provide training for military and civilian personnel. He was a member of the Florida Task Force I Urban Search and Rescue Team, and was on several deployments, including the World Trade Center tragedy. He has been a panel member or given presentations on emergency management issues at multiple conferences and symposiums across the country and abroad.



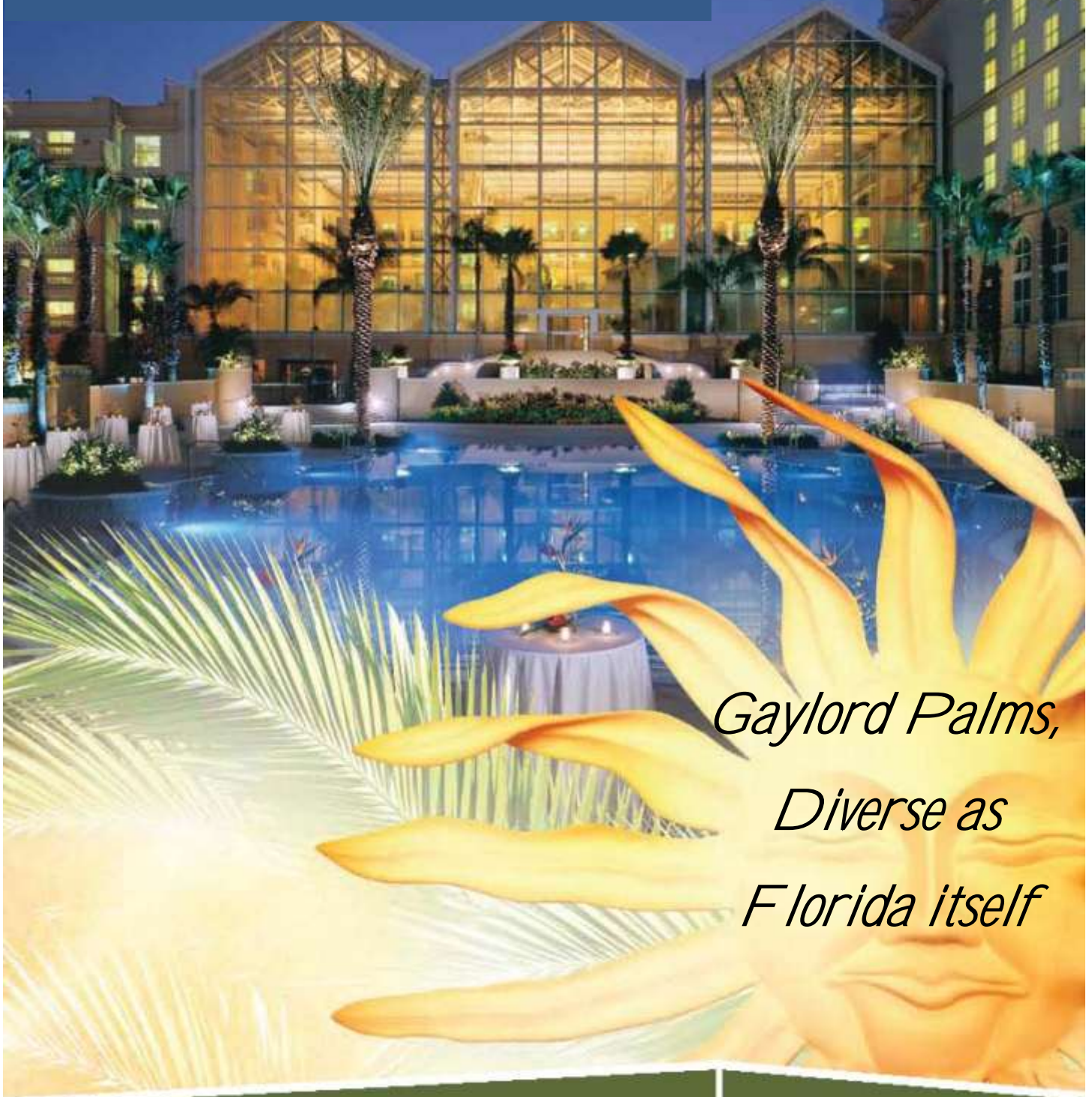

His career began in 1993 as a Corrections Officer at the Leon County Jail. Sergeant Jordan has worked in Uniform Patrol, VICE/Narcotics Unit and Violent Crime Unit. He is currently assigned as a sergeant in the Homeland Security Unit which encompasses criminal street gangs, criminal intelligence and terrorism investigations. The unit is responsible for maintaining and procuring all the Homeland Security Assets in the region as well as working with the Joint Terrorism Task Force and the Regional Domestic Security Task Force. The criminal street gang portion of the unit works with numerous agencies on gang matters including investigating, tracking criminal street gangs and prevention programs. Sgt. Jordan is also an assistant squad leader for the LCSO SWAT Team and Honor Guard.

**Alden Doane** has served over 35 years in emergency services as a fire fighter-paramedic and law enforcement officer. Alden's 23 years of law enforcement experience includes service as a patrol deputy, detective, patrol supervisor, Homeland Security Unit supervisor, JTTF member and Emergency Response Team Commander and instructor. Alden will present on the growing threat of the Sovereign citizen movement, presenting a case he has worked on, and indicators for both public and private sector to help confront this fast-growing threat to the US.
