**Pharmacists Help Improve Patient Safety with Clinical Interventions**

*Quantifi users documented more than 1.7 million interventions in first quarter 2008*

Pharmacy OneSource has 28,262 users currently documenting in Quantifi who have recorded more than \$90 million in cost savings in the first quarter of 2008.

"Our intervention documentation tripled once we started using Quantifi with the interface to our ADT system. Our monthly intervention total has increased to over 1,600 documented entries," said Philip Rioux, Director of Pharmacy at Central Maine Medical Center.
